ADOPTION OF ORDINANCE WITH SUSPENSION OF REQUIREMENT FOR THREE READINGS – Publication of Proposed Ordinance 4 & 20 days

**FIRST READING AND ACTION ON ORDINANCE #43**

WHEREAS Winnebago County Board of Supervisors proposed the adoption and enactment of Ordinance #43 on the 22nd day of February 2022, which action is recorded in the Minutes of the Board of Supervisors; and

WHEREAS the same was duly published in the Buffalo Center Tribune and Lake Mills Graphic, official newspapers of general circulation of the county and comply with 618.3 and 618.14 of the Code of Iowa, on December 22nd, 2021; and

UPON MOTION made by Jensvold and seconded by Durby, a vote was held to suspend the requirement for three successive readings and votes, which motion passed by a vote of a majority of the Board of Supervisors as follows:

NOW THEREFORE the following was read and voted upon by the Board of Supervisors, and it passed by a vote of a majority of the Board of Supervisors;

**WINNEBAGO COUNTY REDISTRICTING  
ORDINANCE #43**

BE IT ENACTED by the Board of Supervisors of Winnebago, Iowa:

Section 1. Purpose:

The purpose of this ordinance is to approve Board of Supervisor Districts drawn in accordance with Chapter 331.210A for Supervisor District Plan 3 as described in Chapter 331.206.

Section 2. Boundaries of Supervisor Districts:

Winnebago County shall have three supervisor districts whose boundaries shall be as follows:

**SUPERVISOR DISTRICT 1**

District 1 shall consist of the following precincts:

Winnebago 1-1: Winnebago 1-2: Winnebago 1-3: Winnebago 1-4

**SUPERVISOR DISTRICT 2**

District 2 shall consist of the following precincts:

Winnebago 2-1: Winnebago 2-2: Winnebago 2-3:

**SUPERVISOR DISTRICT 3**

District 3 shall consist of the following precincts:

Winnebago 3-1: Winnebago 3-2: Winnebago 3-3:

**SECTION 3. STATEMENT OF POPULATION OF EACH DISTRICT:**


**Winnebago District 1 population is 3,558.**

**Winnebago District 2 population is 3,569.**


**Winnebago District 3 population is 3,552.**


