The Winnebago County Board of Supervisors met in session at 9:00 A.M. June 25, 2024 adjourned from June 18, 2024.

Present: Supervisors Durby, Jensvold, and Smith

Absent:

On a motion by Smith and seconded by Jensvold the Supervisors moved to approve the minutes for the June 18, 2024 Board Meeting and approve the agenda for June 25, 2024. All voted aye. Motion carried.

Mike Droessler, Chief Deputy and Steve Hepperly, Sheriff discussed current tasers are outdated and no longer serviced. On a motion by Jensvold and seconded by Smith the Supervisors moved to approve the purchase of new tasers. All voted aye. Motion carried.

Kris Oswald, Deputy Auditor discussed drainage matters. Oswald will see if there are any FEMA issues throughout the county because of the recent rain event.

Scott Meinders, Engineer and Ethan Schutter, Maintenance Superintendent discussed Secondary Road matters including slurry leveling is done. There are at least 55 roads with water over them due to the recent rain event. He will start the FEMA process as it will take at least \$77,000 to repair all the roads.

On a motion by Smith and seconded by Jensvold the Supervisors moved to set the Public Hearing on proposed plans, form of contract, and estimate of cost for the Winnebago County Storage Building project for July 16, 2024 at 9:30 A.M. All voted aye. Motion carried.

On a motion by Jensvold and seconded by Smith the Supervisors moved to approve the Resolution Establishing Weight Restrictions on Winnebago County bridges. All voted aye. Motion carried.

**RESOLUTION No. 06-25-24-20-001**

**Establishing Weight Restrictions on Winnebago County Bridges**

**WHEREAS**, the County Board of Supervisors has authority under Sections 321.236, 321.255 and 321.471 through 321.473 of the Code of Iowa to erect signs for weight restrictions on bridges on any Secondary Road after the completion of an engineering study, and

**WHEREAS** the Winnebago County Engineer has completed or has caused to be completed the Structure Inventory and Appraisal of certain Winnebago County bridges in accordance with the National Bridge Inspection Standards, and

**WHEREAS**, the results of these inspections and reviews indicate that certain structures have reduced load carrying capability and require load restrictions, and

**NOW, THEREFORE, BE IT RESOLVED** by the Winnebago County Board of Supervisors, that the Winnebago County Engineer be authorized to provide, erect and maintain appropriate signs to establish the safe load capacities and width restrictions for the structures listed on Attachment A, which is made a part of this resolution, and that this posting is legal and enforceable under the provisions of the Code of Iowa.

**NOW, THEREFORE, BE IT FURTHER RESOLVED**, this resolution supersedes any previous resolutions pertaining to load limits or width restriction for Winnebago County bridges.
