The Board of Supervisors of Winnebago County, Iowa (the "County"), met on July 2, 2024, at 9:00 a.m., at the Winnebago County Courthouse, Forest City, Iowa, for the purpose of conducting a public hearing on the designation of the expanded Winnebago County UR-2 Economic Development District and on an urban renewal plan amendment.

The Board investigated and found that notice of the intention of the Board to conduct a public hearing on the designation of an expanded urban renewal area and on a proposed urban renewal plan amendment had been published according to law and as directed by the Bond and that this is the time and place at which the Board shall receive oral or written objections from any resident or property owner of the County. All written objections, statements, and evidence heretofore filed were reported to the Board, and all oral objections, statements, and all other exhibits presented were considered. RESOLUTION NO. 7-2-2024-01-01

Resolution to Declare Necessity and Establish an Expanded Urban Renewal Area, Pursuant to Section 403.4 of the Code of Iowa and Approve an Urban Renewal Plan Amendment for the Wim1ebago County UR-2 Economic Development District

WHEREAS, as a preliminary step to exercising the authority conferred upon lowa counties by Chapter 403 of the Code of Iowa (the "Urban Renewal Law"), a county must adopt a resolution finding that one or more slums, blighted or economic development areas exist in the county and that the development of such area or areas is necessary in the interest of the public health, safety or welfare of the residents of the county; and

WHEREAS, the Board of Supervisors (the "Board") of Winnebago County, Iowa (the "County") by resolution previously established the Winnebago County UR-2 Economic Development District (the "Urban Renewal Area") and adopted an urban renewal plan (the "Plan") for the governance of projects and initiatives to be undertaken therein; and

WHEREAS, a proposal has been made which shows the desirability of expanding the Urban Renewal Area to add and include all the property (the "Property") described on Exhibit A hereto; and

WHEREAS, the proposal demonstrates that sufficient need exists to warrant finding the Prope1iy to be an economic development area; and

WHEREAS, an amendment (the "Amendment") to the Plan has been prepared which (1) covers the addition of the Property to the Urban Renewal Area; and (2) authorizes the undertaking of new urban renewal projects in the Urban Renewal Area consisting of (a) using tax increment financing to pay the costs of constructing county road and bridge improvements for the betterment of transportation infrastructure and the promotion of economic development; and

(b) constructing a new building for use by the County's Secondary Roads Department; and

WHEREAS, portions of the Property lie within and within two miles of the incorporated limits of the Cities of Lake Mills, Iowa; Leland, Iowa; Forest City, Iowa; Scarville, Iowa; Rake, Iowa; and Thompson, Iowa (collectively known as the "Cities"), and certain agreements (the "Joint Agreements") have been executed by the Cities to satisfy the consent requirements of Section 403.17 of the Code of Iowa; and

WHEREAS, notice of a public hearing by the Board of the County on the question of establishing the Property as an urban renewal area and on the proposed Amendment for the Urban Renewal Area was heretofore given in strict compliance with the provisions of Chapter 403 of the Code of Iowa, and the Board has conducted said hearing on July 2, 2024; and

WHEREAS, the Planning and Zoning Commission of the County has reviewed and commented on the proposed Amendment; and

WHEREAS, copies of the Amendment, notice of public hearing and notice of a consultation meeting with respect to the Amendment were mailed to the North Iowa, Forest City, and Algona Community School Districts, and the consultation meeting was held on June 11, 2024; and responses to any comments or recommendations received following the consultation meeting were made as required by law;

NOW, THEREFORE, It is Resolved by the Board of Supervisors of Winnebago County, Iowa, as follows:

Section 1. An economic development area as defined in Chapter 403 of the Code of Iowa is found to exist on the Property.

Section 2. The Property is hereby declared to be an urban renewal area, in conformance with the requirements of Chapter 403 of the Code of Iowa and is hereby designated the July, 2024 Addition to the Urban Renewal Area.

Section 3. The development of the Property is necessary in the interest of public health, safety or welfare of the residents of the County.

Section 4. It is hereby determined by this Board of Supervisors as follows:

A. The Amendment and the projects and initiatives described therein conform to the general plan of the County as a whole;

B. Proposed economic development projects described in the Amendment are necessary and appropriate to facilitate the proper growth and development of the County in accordance with sound planning standards and local community objectives.

C. It is not anticipated that any families will be displaced in connection with the County's undertakings under the Plan, but should the need arise, the County will develop a feasible method of relocating such displaced persons into decent, safe and sanitary dwelling accommodations within their means and without undue hardship.

Section 5. The Amendment is made a part hereof and is hereby in all respects approved in the form presented to this Board.

Section 6. The Chairperson and the County Auditor are hereby authorized and directed to execute the Joint Agreements on behalf of the County.

Section 7. All resolutions or parts thereof in conflict herewith are hereby repealed, to the extent of such conflict.

The Urban Renewal Plan (the "Plan") for the Winnebago County UR-2 Economic Development District (the "Urban Renewal Area") of Winnebago County, Iowa (the "County") is being amended for the purposes of (1) adding property to the Urban Renewal Area; and (2) identifying new urban renewal projects to be undertaken therein.

1) Addition of Property. The real property (the "Property") described on Exhibit A hereto is, by virtue of this Amendment, being added as the July, 2024 Addition to the Urban Renewal Area. A map of the location of the Road and Bridge Projects is attached hereto as Exhibit B.

The completed Road and Bridge Projects will cause increased and improved ability of the County to provide adequate transportation infrastructure for the growth and retention of commercial, industrial and agri-business enterprises in the Urban Renewal Area.

Description of Properties to be Acquired in Connection with the Project: The County will acquire such easement territory and right-of-way as are necessary to successfully undertake the Road and Bridge Projects.

Description of Use of TIF: It is anticipated that the County will pay for the Road and Bridge Projects with either borrowed funds and/or the proceeds of an internal advance of County funds on-hand. In any case, the County's obligations (the "Obligations") will be repaid with incremental property tax revenues. It is anticipated that the County's use of incremental property tax revenues for the Road and Bridge Projects will not exceed

\$6,105,000, plus any interest as may accrue on the Obligations.

Description of Project and Project Site: The County will undertake the construction, furnishing, and equipping of a new secondary roads department building (the "Secondary Roads Building Project") on certain real property to be acquired by the County and more particularly described, as follows:

The completed Secondary Roads Department Building Project will have a direct, positive impact on increased and improved commerce and development in the Urban Renewal Area through the provision of enhm1ced secondary roads facilities which will create efficiencies in the planning, design, construction and maintenance of the County's secondary road system.

Description of Use of TIF for the Project: The County will use its urban renewal authority to aid in the authorization of general obligation bonds (the "Bonds") in an approximate principal amount not to exceed \$800,000 to finance the Secondary Roads Department Building Project. The County does not intend to apply incremental prope1iy tax revenues to the repayment of the Bonds. If the County determines to apply incremental properly tax revenues to the repayment of the Bonds in the future, the County will amend the Plan to reflect the required analysis under Section 403.5(2)(b)(1) of the Code of Iowa prior to the using incremental prope1iy tax revenues for the repayment of such Bonds.



RESOLUTION ESTABLISHING A COUNTY COMPENSATION BOARD 07-02-2024-01-01

A resolution by Winnebago County to establish a county compensation board as authorized by Iowa Code Section 331.905.

WHEREAS, pursuant to Iowa Code Section 331.905, as amended in 2024 by Senate File 2442, the county board of supervisors may vote to establish a county compensation board.

WHEREAS, pursuant to this same Code Section, when the board of supervisors establishes a county compensation board, the compensation board shall be comprised of seven members who are residents of the county. Two members shall be appointed by the board of supervisors, one member each by the county auditor, county attorney, county recorder, county treasurer, and county sheriff. The members of the county compensation board shall not be officers or employees of the state or a political subdivision of the state and shall serve staggered terms.

WHEREAS, lots were drawn to determine the duration of initial staggered terms for members of the county compensation board.

NOW, THEREFORE, BE IT RESOLVED, Winnebago County hereby establishes a county compensation board for the county.

BE IT FURTHER RESOLVED, Winnebago County directs each of the elected officials to submit their respective appointments to the board of supervisors by August 1, 2024.

BE IT FURTHER RESOLVED, the representatives of Sheriff, both Supervisor representatives and Treasurer shall serve an initial term of four years and the representatives of Recorder, Attorney, and Auditor shall serve an initial term of two years.

BE IT FURTHER RESOLVED, this resolution shall apply retroactively to July 1, 2024.

APPROPRIATIONS RESOLUTION 07-02-2024-01-01

WHEREAS, it is desired to make appropriations for each of the different officers and departments for the fiscal year beginning July 1, 2024 in accordance with Section 331.434, subsection 6, Code of Iowa.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Winnebago County, Iowa, as follows:

Section 1. The amounts itemized by fund and by department or office on the attached schedule are hereby appropriated from the resources of each fund so itemized, to the department or office listed in the first column on the same line of the attached schedule. Appropriations shall not exceed 100% percent of the total appropriation for each department.

Section 2. Subject to the provisions of other County procedures and regulations, and applicable state law, the appropriations authorized under Section 1 shall constitute authorization for the department or officer listed to make expenditures or incur obligations from the itemized fund, effective July 1, 2024.

Section 3. In accordance with Section 331.437, Code of Iowa, no department or officer shall expend or contract to expend any money or incur any liability or enter into any contract, which by its terms involves the expenditure of money for any purpose in excess of the amounts appropriated pursuant to this resolution.

Section 4. If at any time during the 2024-2025 budget year the Auditor shall ascertain that the available resources of a fund for that year will be less than said fund's total appropriations, she shall immediately so inform the Board and recommend appropriate corrective action.

Section 5. The Auditor shall establish separate accounts for the appropriations authorized in Section 1, each of which account shall indicate the amount of the appropriation, the amounts charged thereto, and the unencumbered balance. The Auditor shall report the status of such account to the applicable departments and officers quarterly during the 2024-2025 budget year.

Section 6. All appropriations authorized pursuant to this resolution lapse at the close of business June 30, 2025.

RESOLUTION FOR INTERFUND OPERATING TRANSFERS 07-02-2024-01-03

WHEREAS, it is desired to authorize the Auditor to periodically transfer sums from the general basic and rural basic fund to the secondary road fund during the 2024-2025 budget year, and

WHEREAS, said transfers must be in accordance with Section 331.432, Code of Iowa,

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Winnebago County, Iowa, as follows:

Section 1. The total maximum transfer from the rural basic fund to the secondary road fund for the fiscal year beginning July 1, 2024 shall not exceed the sum of \$1,546,877.00 and the total maximum transfer from the general basic fund to the secondary road fund for the fiscal year beginning July 1, 2024 shall not exceed the sum of \$0.

Section 2. Within 30 days of being notified of the apportionment of current property taxes, state replacements against levied property taxes, mobile home taxes, military service tax credit replacements, or livestock credit replacements to the general basic or rural services basic funds, the Auditor shall order a transfer from said fund to the secondary road fund.

Section 3. The amount of the transfer required by Section 2 shall be equal to the apportionment made under Section 2 to the general basic or rural services basic fund, respectively, multiplied by the ratio of said fund's total maximum transfer to the secondary road fund, to the sum of said fund's total current property tax levy, total mobile home taxes, total military service tax credit replacements, and total livestock credit replacements.

Section 4. Notwithstanding the provisions of Section 2 and 3 of this resolution, total transfers to the secondary road fund shall not exceed the amounts specified in Section 1.

Section 5. Notwithstanding the provisions of Sections 2 and 3, the amount of any transfer shall not exceed available fund balances in the transferring fund.

Section 6. The Auditor is directed to correct her books when said operating transfers are made and to notify the Treasurer and County Engineer of the amounts of said transfers.
