The new building is almost finished, with a punch list started. Kingland would like reimbursement for temporary power (around \$3,300 as of right now). There is also an issue with grates for drains; the company ordered light duty grates, and the heavy-duty grates cost \$4,000 more. There is a crack in the floor because the floor joints were not deep enough, and a ding in the foundation due to a contractor hitting it with equipment. Bid letting for Rice Lake project is next week. Road projects are continuing.

The discussion regarding using Brody Hopp, IT Director, to aid the City of Lake Mills and the City of Forest City with their E911 systems was tabled until a future date.

During open forum, Geoffry Anderson discussed a Drainage issue. Karla Weiss will check on this for him.
