On a motion by Jensvold and seconded by Durby the Supervisors moved to approve the minutes for the August 12, 2025 Board Meeting and approve the agenda for August 19, 2025. All voted aye. Motion carried.

Amanda Jensen, Victim Witness Coordinator discussed use of Courthouse grounds for Domestic Violence Awareness month in October. On a motion by Durby and seconded by Jensvold the Supervisors moved to approve the use of the Courthouse grounds. All voted aye. Motion carried.
