Kris Oswald, Drainage Clerk discussed Drainage District matters including DD 5 Lats 34 and 36. They are clay tile and may need replaced. A contractor will check on each lateral to prepare an estimate. Aiden Kelly was wondering about the investigation regarding his drainage. Oswald will check with a contractor about possibly adding an intake over the district tile to see if it would help with future rains.

Gary Graber discussed Buffalo Creek. This has been discussed previously to have Buffalo Creek become a drainage district so it can have repairs done. It would be a joint district with Hancock and Kossuth Counties. Graber will find landowners to put up a bond to have an engineer see what the watershed would be. The next step would be to have an informational meeting with potential landowners to see if they would like to proceed with the formation of a district.

There was discussion regarding Official Newspapers. The lowa Code states there will be 2 approved newspapers. The Supervisors want to do some research on this topic. This will be tabled for now.

On a motion by Durby and seconded by Jensvold the Supervisors moved to approve the following Auditor's transfers: #4028 from Rural Basic to Secondary Roads in the amount of \$105,042.06 and #4029 from Rural Basic to Winnebago County Fair Association in the amount of \$3,977.68.
